Exchange Student Program

SNU Student Exchange Program is for **students from SNU's partner universities** who wish to study at SNU for one or two semesters and transfer credits to their home university program. You must first be selected by your home university and be nominated.

Application

1. Eligibility

- 1) Qualification
 - Applicants must currently be enrolled in at least **second semester** of the home university program (= have completed at least one semester before they apply)
 - * We cannot thus accept graduate students who are enrolled in the first semester of the Master's program at their application stage. In other words, you must have at least one semester's grades on your transcript.
 - GPA requirement. (from Fall 2020's admission)

- Language: No certification is required, but a fluent level of either English or Korean language proficiency is highly recommended.

^{*} Dept. of Korean History/Psychology/Statistics/Pharmacy requires applicants to provide a proof of Korean language proficiency. A satisfactory level of Korean language ability should be Level 5 or above of the official Korean Language Proficiency Test, TOPIK.

2) Academic Programs

<u>All applicants for exchange/visiting program must choose one college and department</u> as their affiliation and in general, applicants choose one that most suits their academic background or study abroad purpose. Students can, however, take other unrestricted courses from different colleges and departments.

- Applicants from SNU's university-wide partners can in principle apply for any academic program. Please, however, note that applicants must read the restrictions below thoroughly before making a department choice and applicants may be required to change their choice if SNU finds it difficult to accommodate it.
- Applicants from SNU's college/department-level parters must choose the specific college and department. More information:

3) Restriction

- * Applicants who wish to study in the discipline of **Medicine**, **Pharmacy**, **Dentistry**, **Nursing**, **Music**, **Fine Arts**, **and MBA** must, in advance, be advised of the program availability by SNU exchange program coordinators.
- College of Business Administration is restricted to students who are currently majoring in business or economics at home university.

Considering the current lack of course capacity for exchange students, CBA has decided that from Fall 2019's admission, they will **strictly control the number of accepted exchange students to CBA** to provide quality education and better administrative support. In this regard, it is more likely than the past that students who apply for CBA **might get rejected** during the screening procedure.



- Undergraduate applicants for Dept. of Computer Science and Engineering must have earned at least 15 credits in CSE-related courses (one credit corresponds to 15 lecture hours or 30 lab hours). This must be explicitly shown on the official transcript; if not, additional proof must be presented by the student.

Starting from Spring 2020's admission, CSE has decided to **control the number of accepted exchange students on the undergraduate-level**, due to lack of course capacity and placement. During the screening procedure, various criteria (including GPA) could be used in determining acceptance.

- Dept. of Korean History/Psychology/Statistics/Pharmacy requires applicants to provide a proof of Korean language proficiency. A satisfactory level of Korean language ability should be Level 5 or above of the official Korean Language Proficiency Test, TOPIK.
- College of Law is NOT available to undergraduate level students from Spring 2018.
 - *School of Law, a specialized law school for graduate level students, instead, will be open to undergraduate students from Fall 2018. Please note that these undergraduate students will be enrolled as graduate (Master's) students in SNU law school during their study.
- Dept. of Vocal Music is restricted to students who are currently studying vocal music at home university.
- College of Medicine is NO longer available to exchange students.
- School of Dentistry is open only to graduate students currently enrolled in a Master's program at School of Dentistry or the equivalent at home university.
- Graduate School of Business (MBA program) is only offered for the Spring semesters (not offered for the Fall Semesters). It is also restricted to current full-time MBA applicants at home university. Applicants must be aware that the academic system of MBA program differs from that of other programs (Details to be individually announced from the MBA coordinator). 3. Document Submission

- Important Notes: Exchange program applicants can complete application by online submission of the required documents. However, visiting program applicants must complete both online and postal submission of the documents.
- All documents should be submitted in original or verified as an official copy (stamped), and should be in Korean or in English. If the documents are not in Korean or in English, applicants must have them translated in Korean or in English and certified and sealed by the authorized body.
- Application documents are non-returnable once submitted to SNU.
- Please be aware that SNU cannot process applications if there is any missing document or information.

4. Screening Procedure

SNU OIA initially receives and reviews all applications to see if all the requirements have been met. The applications are then forwarded to the screening committee of each department that applicants chose to apply for. **During the assessment, not every nominee will be successful**; some may be rejected if their credentials do not meet the committee's expectation. When the decisions are made, OIA will announce the acceptance results to all applicants and home university. *Please note that OIA is not responsible for the selection process and its results.*

5. Acceptance Package

Acceptance package encloses a Certificate of Admission (CoA, for non-Korean nationals), an official Letter of Acceptance, and other information necessary for pre-arrival. The package will be electronically sent to the accepted students shortly after the acceptance announcement.

2. Courses

Regular Curriculum

- The majority of courses are taught in Korean but each college and department offers some courses in English as well. The course catalog for the new semester is available at the beginning of January and July each year. Until then, applicants will have to refer to the previous year's catalog.
- Undergraduate students can take courses up to 18 credits and graduate students can take up to 12 credits. There is no minimum credit requirement that SNU imposes on exchange students.
- Korean universities use a credit system based on the number of lecture hours and 1 credit usually amounts to 15 lecture hours. For credit transferability and conversion criteria, applicants must refer to their home university's academic policy on study abroad.
- Course registration is held online a month before the semester begins; it is on a first-come first-served basis and exchange/visiting students are not guaranteed with registering courses they wish to take.

Korean Language Program (KLP)

SNU Language Education Institute (LEI) offers credit-bearing Korean Language Programs (KLP) on a fee-paying, extracurricular basis. For exchange students taking KLP, SNU OIA will provide financial support to encourage international students to learn Korean language and culture.

3. Academic Transcript

For exchange students, SNU OIA will send one official academic transcript to home university by the Mid-August and February for each semester. Visiting students, however, must request for its issuance in person at SNU Division of Educational Affairs.

Student Life

1. Visa & Immigration

Student Visa

A student visa (D-2) is required for every non-Korean student who will be studying in Korea, and it must be acquired before entering Korea. In most cases, exchange/visiting students can acquire their D-2 visa easily when they present the Certificate of Admission (CoA), issued by SNU, to the relevant officials in home country. Alien Registration

After arrival in Korea, all international students who stay for more than 90 days are required to apply for alien registration through Korean immigration office. More detailed information will be provided before arrival.

2. Housing

On-Campus Housing

Exchange students can apply for on-campus housing, and there are two types of residence halls available on the main campus. More information: https://snudorm.snu.ac.kr/en/

- Gwanak Residence Halls: Double rooms or shared flats (double rooms) available for undergraduate students; single or double rooms available for graduate students
- Global Residence Halls: Double rooms or shared flats (single rooms) available for undergraduate and graduate students

3. Health Care & Well-being

Health Insurance

From March 2021, all non-Korean international students are mandatorily and automatically subscribed to Korea's National Health Insurance (NHIS) upon the date of alien registration. Given that administrative process of alien registration takes about a month, it is expected that exchange/visiting students will be subscribed to KNHIS from April (for Spring semester) or from October (for Fall semester). NHIS will charge about 40,000 KRW (about 35 USD / 30 Euro) per month.

To fill the gap between students' arrival date and the NHIS's application date, it is strongly recommended to purchase a travel/study abroad medical insurance that covers until late-April (or late-October), which should cover potential medical expenses incurred by sickness and accident during the stay in Korea. No additional financial assistance can be provided by SNU.

SNU On-campus Health Service Center (SNUHSC)

Conveniently located in the center of the campus, SNUHSC runs a comprehensive primary care clinic and various specialty clinics in cooperation with SNU Hospital (SNUHC) and SNU Dental Hospital (SNUDH). It also provides a range of health checkup, immunizations, and medical tests, including Family Medicine, Psychiatry, Ear/Nose/Throat, Dermatology, Ophthalmology, Gynecology, Orthopedics, Smoking Cessation Clinic, and Dentistry. Mental Health

- SNU Health Service Center. SNUHSC offers multiple therapeutic programs, including stress clinic, neuro-feedback, biofeedback, and group therapy, along with various campaigns and education programs.
- SNU Center for Campus Life & Culture: The center offers a variety of types of professional counseling programs, including English counseling services for international students.

4. Student Support & Activities

S-CARD

With a student ID card, namely S-CARD, exchange/visiting students can take advantage of access to on-campus facilities and get a discount at designated cafeterias.

SNU Buddy Program

SNU Buddy was established in 2005 to help international exchange and visiting students settle in SNU and to build a real friendship and network. SNU domestic and international students by themselves organize intercultural events activities throughout the semester. Sign-up notice will be e-mailed to all incoming exchange/visiting students before the semester starts.



Student Club/Society

There are a number of student activities and sports clubs at SNU, including musical bands, choir, orchestra, dance, painting, photography, student newspaper, traditional Korean music, travel clubs and SNU International Students Association (SISA). Sports clubs ranging from fencing, golf, basketball, rugby, scuba-diving, snowboard, ski, horse riding, baseball, yacht, judo, kendo, soccer, taekwondo, tennis, etc.

NOMINATION & APPLICATION PROCEDURE

1. How to Nominate? NOMINATION LINK: https://forms.gle/JALAPTD7W3qR2t1fA

If you have any nominee(s) for Spring 2024(one semester) or from Spring 2024 to Fall 2024(two semesters, one full year), please provide us with information of your nominee student(s) **through college and department exchange manager** no later than **September 10, 2023**.

- *For college and departmental-level exchange, submit the nomination through college and department exchange manager.
- *If you have difficulty accessing the above link, please fill out your University-level nominees' information to the attached spreadsheet and submit it via email(yunju96@snu.ac.kr). If you have a college-level or departmental-level exchange partnership, please send the nomination sheet to the manager at that college/department.
- *Please make sure your candidate(s) meet(s) the entry requirement (both semester condition and department restrictions) stated in the attached fact sheet. Especially, please note that we cannot accept graduate students who didn't complete at least one semester at their "graduate" program. Graduate students must be able to prove that they have completed at least one semester of the graduate program at the application stage.
- ** Students who have postponed their placement must be nominated through this survey/spreadsheet again. These students must re-apply with updated documents and go through the screening procedure again.

2. After Nomination?

After the nomination deadline, <u>September 10</u>, the nominated student(s) will receive an application guideline, along with instructions regarding the online application process, from the coordinators at SNU Office of International Affairs (central international office), SNU. In other words, we do not send out the application instructions right after we receive nomination from each university. They will be sent out altogether a few days after the nomination deadline.

3. How to Apply?

The application deadline is <u>September 25, 2023</u>. Only the online application will be required for the application. Please make sure that your students carefully read through the attached guideline and prepare for the application process in advance.

*GSIS applicants must have their recommendation letter be submitted to SNU coordinators in the following way:

Candidate(s) must submit the sealed recommendation letter to their home university's exchange program coordinator so that the coordinator opens the letter and sends us its scanned copy. We ask you to send the copy to the following persons at the Office of International Affairs, SNU:

4. Selection Process

If students successfully finish their application, their application documents will be carefully reviewed by each department's selection committee. They will decide whether students will be accepted to the exchange program or not. Please note that acceptance to the exchange program is not guaranteed.

5. More Information on Course Catalog?

Students can find information on the courses that were provided in the previous semesters through our course registration website http://sugang.snu.ac.kr. Attached you can find the course search instruction as well.

*IMPORTANT NOTES FOR AY2023/24:

- Please make sure that applicant(s) have completed at least one semester on the current program at their application stage. This means that <u>if the study abroad semester is applicant(s)' first semester of Master's program, they are not eligible for our program as a graduate exchange student.</u>
- All nominated students will be screened by each department's selection committee comprised of its faculty members. <u>Acceptance to the exchange program is not guaranteed.</u>
- Please ensure that all your nominees read the eligibility and restrictions stated on the fact sheet thoroughly before they apply. Some departments have specific restrictions including:
 - Starting from Spring 2020's admission, Dept. of Computer Science and Engineering (CSE) has decided to control the number of accepted exchange students on the undergraduate-level, due to lack of course capacity and placement. Undergraduate applicants for CSE must have earned at least 15 credits in CSE-related courses (one credit corresponds to 15 lecture hours or 30 lab hours). This must be explicitly shown on the official transcript; if not, additional proof must be prepared by the student.
 - Considering the current lack of course capacity for exchange students, College of Business Administration (CBA) has decided that from Fall 2019's admission, they will strictly control the number of accepted exchange students to CBA and we would like to inform you that it is more likely than the past that students who apply for CBA might get rejected during the screening procedure. (Applying to SNU's university-wide partners only)
 - Course registration priority for some of the undergraduate Business Administration courses (See attachment, "College of Business Administration_Requisite Subject for Major") will be given to degree-seeking domestic students first, since these courses are requisite towards their graduation. Exchange students can take these courses only when there are extra spots available. Please advise your nominee(s) of this issue and make sure that they have a Plan B.
 - Dept. of Korean History/Psychology/Statistics/Pharmacy requires applicants to provide a proof of Korean language proficiency.
 - College of Law is NOT open to undergraduate students from Spring 2018, as the undergraduate level does not exist any longer. Instead, School of Law, a specialized law school for graduate level students, will be open to undergraduate level students. Please note that these undergraduate students will be enrolled as graduate (Master's) students in SNU law school during their study. These students must be advised that the credits they take at SNU should be transferred under their current undergraduate program, not their prospective graduate program.
 - When there are applicant(s) for Medicine/Pharmacy/Dentistry/Nursing/Music/Fine Arts/Global MBA, please let us know before you make nomination as these are relatively more restricted than the others. We will check the availability and capacity of the department in advance.

1. HOW CAN I APPLY FOR THE STUDENT EXCHANGE PROGRAM?

To apply for SNU student exchange program, your home university must first nominate you to SNU. Once nominated, SNU or your home university will provide you with the details about the application procedure. Please visit the following website to see more information.

2. WHY DO I HAVE TO CHOOSE A SPECIFIC COLLEGE AND DEPARTMENT DURING THE ONLINE APPLICATION PROCESS?

Once we receive all the application materials, we will forward them to the specific department that you have selected during the online application process. The department's screening committee will review your credentials on the basis of the submitted documents and will make a decision whether to accept you or not. Therefore, it is important for you to choose a college and department that most suits your academic background and study purpose.

Once accepted, you will be admitted to the college and department as a non-degree-seeking exchange student and can access modules and facilities with the same access with the one that domestic students have.

3. HOW CAN I APPLY FOR THE ON-CAMPUS DORMITORY? IS DORMITORY SPACE GUARANTEED?

Dormitory application guide will be provided to the students who are offered acceptance from SNU. While all exchange students can apply for the on-campus dormitory, *Gwanak Residence Halls* and *Global Residence Halls*, the room assignment is not guaranteed due to lack of spaces. 4. HOW CAN I FIND AN OFF-CAMPUS HOUSING IN CASE I AM NOT ACCEPTED TO ON-CAMPUS DORMITORY?

5. HOW CAN I REGISTER FOR COURSES?

Course registration guide will be provided to the students who are offered acceptance from SNU. In general, course registration is scheduled at the beginning of August for Fall semester and at the beginning of February for Spring semester. Undergraduate students can take up to 18 credits, while graduates can take up to 12 credits.

6. WHERE CAN I FIND THE COURSE LIST AND SYLLABI?

You can find the course list and syllabi on SNU course registration website. Please note that the final course catalog is updated online every July for Fall semester and January for Spring semester. Until then, you should refer to the catalogs of the previous semesters.

7. CAN I TAKE COURSES OUTSIDE OF MY DEPARTMENT?

Yes, you can take courses that are provided by other colleges and departments. However, please note that some courses have restrictions. Thus, it is advised to contact the instructor in advance to ask whether it will be approved to register/take the course.

8. HOW CAN I OBTAIN ACADEMIC TRANSCRIPTS AT SNU?

Basically, you can get issued your transcript via mySNU portal which is an official administrative website of SNU members. The detailed guidance is distributed at each end of the semester. SNU OIA will also send one original copy of the transcript to your home university by the end of August and the end of February for Fall and Spring semesters.

9. IS THERE A KOREAN LANGUAGE PROGRAM AVAILABLE FOR EXCHANGE STUDENTS?

Exchange Students can take Korean Language Programs provided by the SNU Language Education Institute on a fee-paying basis. OIA will provide a full or partial financial support for the tuition fee for exchange students. To exchange students with Korean Studies major at home university, OIA offers a full tuition fee waiver. Please visit the following website to see the program information.

10. WHEN CAN I APPLY FOR A VISA?

All the non-Korean exchange students must apply for student visa (D-2) after receiving the acceptance packet from SNU. You have to visit your local Korean embassy/consulate with Certificate of Admission (CoA) which is to be enclosed in the packet along with other supporting documents. Please contact your nearest Korean Embassy/Consulate for more details on the visa application process.

11. CAN I STUDY IN KOREA WITH A TOURIST VISA?

No, it is illegal for you to participate in student exchange program with a tourist visa. You must obtain a student visa (D-2) before your arrival in Korea to study at SNU. If you have already obtained a different type of visa, you must check with the Korean Immigration Office in advance to confirm if your existing visa type is applicable for continuing the student exchange program.



For the undergraduate modules classified as "Requisite Subject for Major" above, only the degree-seeking students are eligible for the registration for the first four days of the course registration period. Exchange/visiting students who are accepted to College of Business Administration will have access to the left spots of the courses on the last day of the course registration period only. The additional registration opportunities for the rest of the exchange/visiting students will be given after the semester starts.

In general, it is never easy to get a seat for the courses listed above, so it is advised you have alternative sets of courses in case you fail to register for these courses. SNU does not recommend students who are required to take more than two of these courses during the study abroad to apply for SNU.

Please note that all students have the same access to the other courses of Business Administration for the entire registration period.
